YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the "Committee"), acting by and through the State Treasurer, at the Office of the State Treasurer, Legislative Building, Second Floor, Room 230, Olympia, commencing at approximately 11:00 A.M., on the 30<sup>th</sup> day of September, 2015, will consider for approval the following proposed Bond Sale Resolutions:

1. Resolution No. 1175 awards the sale of \$458,800,000, more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2016A-1, as authorized by Resolution No. 1170 of the Committee, Chapter 179, Laws of 2008; Chapter 49, Laws of 2011, 1<sup>st</sup> Sp. Sess.; Chapter 20, Laws of 2013, 2<sup>nd</sup> Sp. Sess.; Chapter 37, Laws of 2015, 3<sup>rd</sup> Sp. Sess.; and Chapter 39.42 RCW.
2. Resolution No. 1176 awards the sale of \$39,000,000, more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2016A-2, as authorized by Resolution No. 1170 of the Committee; Chapter 49, Laws of 2011, 1<sup>st</sup> Sp. Sess.; Chapter 20, Laws of 2013, 2<sup>nd</sup> Sp. Sess.; Chapter 37, Laws of 2015, 3<sup>rd</sup> Sp. Sess.; and Chapter 39.42 RCW.
3. Resolution No. 1177 awards the sale of \$191,995,000, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Bonds, Series 2016B, as authorized by Resolution No. 1171 of the Committee, Chapter 147, Laws of 2003 (RCW 47.10.861); Chapter 315, Laws of 2005 (RCW 47.10.873); and Chapter 39.42 RCW.
4. Resolution No. 1178 awards the sale of \$60,710,000, more or less, of State of Washington General Obligation Bonds, Series 2016T (Taxable), as authorized by Resolution No. 1170 of the Committee, Chapter 167, Laws of 2006, Chapter 20, Laws of 2013, 2<sup>nd</sup> Sp. Sess.; Chapter 37, Laws of 2015, 3<sup>rd</sup> Sp. Sess.; and Chapter 39.42 RCW.
5. Resolution No. 1179 awards the sale of \$193,775,000 more or less, of State of Washington Various Purpose General Obligation Refunding Bonds, Series R-2016A, as authorized by Resolution No. 1172 of the Committee, and Chapters 39.42 and 39.53 RCW.
