YOU ARE HEREBY NOTIFIED that the State Finance Committee of the state of Washington (the "Committee"), acting by and through the State Treasurer, at the Office of the State Treasurer, Legislative Building, Second Floor, Room 230, Olympia, commencing at approximately 11:00 AM, on the 18th day of July, 2012, will consider for approval the following proposed Bond Sale Resolutions:

1. Resolution No. 1129 awards the sale of \$197,400,000¹, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Bonds, Series 2013B-2, as authorized by Resolution No. 1115 of the Committee, Chapter 321, Laws of 1998 (Referendum 49 (RCW 47.10.843)); Chapter 147, Laws of 2003 (RCW 47.10.861); Chapter 315, Laws of 2005 (RCW 47.10.873); and Chapter 39.42 RCW.
2. Resolution No. 1130 awards the sale of \$274,105,000², more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2013A, as authorized by Resolutions Nos. 1114 and 1128 of the Committee, Chapter 14, Laws of 1989 1st Ex. Sess.; Chapter 15, Laws of 1990, 1st Ex. Sess.; Ch. 147, Laws of 2003; Chapter 167, Laws of 2006; Chapter 498, Laws of 2009; Chapter 49, Laws of 2011 1st Sp. Sess.; Chapter 1, Laws of 2012 2nd Sp. Sess.; and Chapter 39.42 RCW.
3. Resolution No. 1131 awards the sale of \$197,400,000¹, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Bonds, Series 2013B-1, as authorized by Resolution No. 1115 of the Committee, Chapter 321, Laws of 1998 (Referendum 49 (RCW 47.10.843)); Chapter 147, Laws of 2003 (RCW 47.10.861); Chapter 315, Laws of 2005 (RCW 47.10.873); and Chapter 39.42 RCW.
4. Resolution No. 1132 awards the sale of \$40,585,000², more or less, of State of Washington General Obligation Bonds, Series 2013T (Taxable), as authorized by Resolution No. 1114 of the Committee, Chapter 167, Laws of 2006; Chapter 49, Laws of 2011 1st Sp. Sess.; and Chapter 39.42 RCW.

¹ Preliminary, subject to change. This represents the preliminary aggregate principal amount of the Series 2013B-1 Bonds and the Series 2013B-2 Bonds. The Series 2013B-2 Bonds will be sold by negotiated sale. The pre-marketing of Series 2013B-2 Bonds will be in advance of the sale date for the Series 2013B-1 Bonds. The Series 2013B-1 Bonds will be the amount that are not sold by negotiated sale. As described in this Official Notice of Sale, the state will provide notice of the expected principal amount of Series 2013B-1 Bonds the day before the sale.
