YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the “Committee”), acting by and through the State Treasurer, at the Office of the State Treasurer, Legislative Building, Second Floor, Room 230, Olympia, commencing at approximately 11:00 A.M., on the 29<sup>th</sup> day of August, 2018, will consider for approval the following proposed Bond Sale Resolutions:

1. Resolution No. 1214 awards the sale of \$262,915,000, more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2019A, as authorized by Resolution No. 1209 of the Committee; Chapter 179, Laws of 2008; Chapter 167, Laws of 2006; Chapter 49, Laws of 2011, 1st Sp. Sess.; Chapter 20, Laws of 2013, 2nd Sp. Sess.; Chapter 37, Laws of 2015, 3rd Sp. Sess.; Chapter 3, Laws of 2018; and Chapter 39.42 RCW.
2. Resolution No. 1215 awards the sale of \$93,435,000, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Bonds, Series 2019B, as authorized by Resolution No. 1196 of the Committee; Chapter 147, Laws of 2003 (RCW 47.10.861); Chapter 315, Laws of 2005 (RCW 47.10.873); and Chapter 39.42 RCW.
3. Resolution No. 1216 awards the sale of \$145,780,000, more or less, of State of Washington General Obligation Bonds, Series 2019T (Taxable), as authorized by Resolution No. 1209 of the Committee; Chapter 37, Laws of 2015, 3rd Sp. Sess.; Chapter 3, Laws of 2018; and Chapter 39.42 RCW.

The results of the foregoing bond sales will be posted on the State Treasurer’s website promptly following approval of the Bond Sale Resolutions by the State Treasurer on behalf of the Committee.
