YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the “Committee”), acting by and through the State Treasurer, at the Office of the State Treasurer, Legislative Building, Second Floor, Room 230, Olympia, commencing at approximately 11:00 A.M., on the 10<sup>th</sup> day of September, 2019, will consider for approval the following proposed Bond Sale Resolutions:

1. Resolution No. 1227 awards the sale of \$490,405,000, more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2020A, as authorized by Resolution No. 1222 of the Committee; Chapter 167, Laws of 2006; Chapter 179, Laws of 2008; Chapter 37, Laws of 2015, 3<sup>rd</sup> Sp. Sess.; Chapter 3, Laws of 2018; Chapter 414, Laws of 2019; and Chapter 39.42 RCW.
2. Resolution No. 1228 awards the sale of \$224,495,000, more or less, of State of Washington Motor Vehicle Fuel Tax & Vehicle Related Fees General Obligation Bonds, Series 2020B, as authorized by Resolution No. 1225 of the Committee; Chapter 45, Laws of 2015, 3<sup>rd</sup> Sp. Sess. (RCW 47.10. 889-.895); and Chapter 39.42 RCW.
3. Resolution No. 1229 awards the sale of \$39,575,000, more or less, of State of Washington General Obligation Bonds, Series 2020T (Taxable), as authorized by Resolution No. 1222 of the Committee; Chapter 3, Laws of 2018; Chapter 414, Laws of 2019; and Chapter 39.42 RCW.

The results of the foregoing bond sales will be posted on the State Treasurer’s website promptly following approval of the Bond Sale Resolutions by the State Treasurer on behalf of the Committee.
