YOU ARE HEREBY NOTIFIED that the State Finance Committee of the State of Washington (the "Committee"), acting by and through the State Treasurer, at the Office of the State Treasurer, Legislative Building, Second Floor, Room 230, Olympia, commencing at approximately 11:00 A.M., on the 26<sup>th</sup> day of September, 2017, will consider for approval the following proposed Bond Sale Resolutions:

1. Resolution No. 1199 awards the sale of \$334,010,000 more or less, of State of Washington Various Purpose General Obligation Bonds, Series 2018A, as authorized by Resolution No. 1170 of the Committee; Chapter 167, Laws of 2006; Chapter 20, Laws of 2013, 2nd Sp. Sess.; Chapter 37, Laws of 2015, 3rd Sp. Sess.; and Chapter 39.42 RCW.
2. Resolution No. 1200 awards the sale of \$101,015,000, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Bonds, Series 2018B, as authorized by Resolution No. 1196 of the Committee; Chapter 147, Laws of 2003 (RCW 47.10.861); Chapter 315, Laws of 2005 (RCW 47.10.873); and Chapter 39.42 RCW.
3. Resolution No. 1201 awards the sale of \$36,725,000 more or less, of State of Washington General Obligation Bonds, Series 2018T (Taxable), as authorized by Resolution No. 1170 of the Committee; Chapter 37, Laws of 2015, 3rd Sp. Sess.; and Chapter 39.42 RCW.
4. Resolution No. 1202 awards the sale of \$27,530,000, more or less, of State of Washington Various Purpose General Obligation Refunding Bonds, Series R-2018A, as authorized by Resolution No. 1197 of the Committee, and Chapters 39.42 and 39.53 RCW.
5. Resolution No. 1203 awards the sale of \$29,530,000, more or less, of State of Washington Motor Vehicle Fuel Tax General Obligation Refunding Bonds, Series R-2018B, as authorized by Resolution No. 1197 of the Committee, and Chapters 39.42 and 39.53 RCW.

The results of the foregoing bond sales will be posted on the State Treasurer's website promptly following approval of the Bond Sale Resolutions by the State Treasurer on behalf of the Committee.
